

"Medical" Marijuana / MariHuana "Medicinal"

PILL MILL LOOPHOLE
Amendment 2 doesn't have a local option to allow communities to decide where or how many pot shops they want. It places no restrictions on the location of seedy pot shops. Like Florida's infamous Pill Mills, look for Pot Shops to spring up in your neighborhood shopping centers. Florida's Department of Health says Amendment 2 will cram nearly 2,000 pot shops into Florida.

DRUG DEALER LOOPHOLE
Amendment 2 allows so-called "caregivers" to administer pot without medical training. Worse still this "new" amendment doesn't limit the number of "patients" or customers. You won't find a licensed pharmacist at your local "medical marijuana treatment center." Instead, a pot user called a Budtender will help you pick out your favorite buds. This isn't medicine; it's just street pot.

POT LEGALIZATION LOOPHOLE
Amendment 2 doesn't require a doctor's prescription just a flimsy "recommendation." It also allows someone to obtain pot for alleged conditions of the "same kind, class or comparable to those enumerated." This opens Pandora's box to almost anything. That's why in California their medical pot law shows only 3% of users have "debilitating" conditions like cancer, and the average user is a 32-year-old white male with a history of drug or alcohol use.

It replaces pharmacists with DRUG DEALERS, no real prescription!

- Allows anyone over 21 with a "card" to "administer" Marijuana, no real license.
- Doesn't require a doctor's prescription. (Read: AX, S29,(a), (7)).

Authorizes selling "kid-friendly pot" disguised as candy or gummies!



Poison Control has reported over 4,000 children intoxicated with Marijuana, in less than 1 year.

- Doesn't allow communities the right to refuse it
- It places NO local restrictions for sales.
